Radon is a naturally occurring, radioactive gas.


- It cannot be seen, smelled or tasted.
- It may seep into your home from the rocks below.
- It is the second leading cause of lung cancer.

Radon is a problem in many areas in Kentucky, including Warren county.




Smoking and radon:

Breathing radon is dangerous, but it is even *more* harmful when you also breathe tobacco smoke.



In Warren County:



Blue dots show homes already tested for radon.



More homes in Warren County need to be tested.

To Do List:

- ✓ **TEST** your home for radon.
- ✓ **TALK** with a health care provider about your results.
- ✓ **FIX** your home if the level is high. Call a certified radon professional.
- ✓ **ASK** people to smoke outside.
- ✓ **TELL** your loved ones about the dangers of radon and tobacco smoke.




Kentucky Counties With Radon Programs


Radon Levels by Rock Type (pCi/L)

Monetizing Valuation of Our Radon Risk Potential Maps in Kentucky

- Value of information (VOI) techniques to estimate the economic impacts associated with lung cancer for scenarios with and without access to the radon potential maps.
- 9-step process to estimate the monetary value in lives saved through the use of geologic maps to convey radon potential risk in Kentucky



The Bottom Line

Our geologic radon potential maps

- increase radon testing & radon mitigation
- lower new cases of lung cancer and years of potential lives lost
- save \$2.4M - \$3.8M per year



FRESH Findings

Homeowners who received FRESH were more ready to test for radon and air nicotine and to mitigate for radon compared to controls. The effect diminished after 9 months.

- Including a booster at 9 months after FRESH may improve the remediation rate, thereby decreasing exposure.

Those who perceived higher synergistic risk (tobacco smoke + radon) were more likely to take action to remediate for radon over time.

- Urgent need to maximize provider-patient conversations about these combined environmental hazards

Providing free in-person test kits in primary care settings with telephonic report back improved readiness to take action to remediate for radon and SHS.



House Bill 420

Updates language in **KRS 211.9101** to require radon professionals to be certified before performing mitigation or home alterations

- Sponsored by Rep. Adam Bowling (R—Bell, Harlan [partial])
- Attempt to ensure radon mitigation quality and safety of residents with radon concerns or risk
- **Requirements:**
 - Complete a registration process prescribed by CHFS through promulgation of an administrative regulation
 - Provide proof of a general liability insurance policy
- Assigned to the House Veterans, Military Affairs & Public Protection Committee and Senate Health & Welfare Committee
- **Passed March 14, 2019**
- **Signed by Gov. Bevin on March 26, 2019**

Radon Litigation Dismissal

Civil Action regarding **KRS 211.9101** dismissed in Franklin Circuit Court

- International Association of Certified Home Inspector, et al. v. Cabinet for Health and Family Services, et al.
 - Dismissed April 2, 2019
