KCC Partner Legislative Priorities for 2024

Invest in Tobacco Control

Increasing funding for Kentucky's Tobacco Prevention and Cessation Program to \$10 million annually is crucial to prevent kids from starting to use tobacco and help people already addicted to tobacco quit. According to projections from the Campaign for Tobacco-Free Kids, this increase would prevent 2,400 kids from growing up to be adults who smoke and save the state \$38.4 million in future health care expenditures. ACS CAN urges Kentucky to increase funding for its vital tobacco prevention and cessation program to \$10 million annually to reduce taxpayer costs, protect kids, and save lives. Young Leaders of Kentucky Say No to Big Tobacco - Action Needed

Support a strong Tobacco 21 enforcement program that incorporates a retailer database, annual compliance checks, and severe penalties for non-compliance, 2. Allocate resources to educate retailers on up-to-date, applicable laws which regulate the sales of nicotine products in Kentucky, and 3. Campbellsville Smoke-Free Ordinance

The Campbellsville City Council is considering amending their longstanding comprehensive smoke-free ordinance to allow indoor smoking rooms in businesses that serve alcohol. A first reading occurred on November 20th and a second and final reading will take place on Monday December 18th at 6:00 pm. Healthy Farm and Food Innovation Fund

Healthy Farm and Food Innovation Fund (HFFIF) would create a structured state fund capable of receiving state, federal, and private philanthropy funds to help Kentucky address food and nutritional security. This legislation would set aside a small amount of the state's general funds so that food access programs using Kentucky grown products can utilize to meet federal grant match requirements. This would support programs such as Kentucky Double Dollars, Senior Farmers Market Nutrition Program, and Fresh RX for MOMs.

Community Farm Alliance's Current Policy Work HFFIF Toolkit

Kentucky Food Action Network (KFAN) 2024 Policy Priorities

KFAN prioritizes policies that improve nutrition assistance programs and that impact low-income children, adults and seniors in addition to Kentuckians returning home from incarceration.

- Priority 1: Help feed more Kentuckians by improving Kentucky's safety net
- Priority 2: Feed more hungry children and support education by providing more free school meals.
- Priority 3: Support local agriculture and food systems and feed more hungry Kentuckians by establishing the Healthy Farm and Food Innovation Fund (HFFIF).
